ORDER.

In the matter : CWP No. 3060/2026 titled as Sarika Awasthi, TGT(Med) VS State of H.P. & others.

The Petitioner Smt. Sarika Awasthi, TGT(Med) filed CWP No. 3060/2026 titled as, Smt. Sarika Awasthi, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS, Deori to District Mandi. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 16.03.2026, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*“Without making any observation on the merit of the case, this writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-6, shall be decided by the competent Authority sympathetically, in light of the aermments made therein within a period of 6 weeks from today , by passing a speaking order, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly.”*

As per the directions of the Hon'ble High Court, the petitioner was called for a personal hearing on 27.04.2026. The petitioner attended the hearing on the scheduled date and time and submitted a representation seeking her adjustment in District Hamipur.

From the perusal of the record, it reveals that Smt. Sarika Awasthi, TGT (Med.) is working in GSSS, Deori District Mandi which falls in soft area. As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 “Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
