ORDER

Whereas the Hon'ble High Court of Himachal Pradesh vide judgment dated 07.01.2026 in CWP No. 15271/2025 titled as Jeevan Lal Vs State of HP & others directed that:-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation of the petitioners (Annexure P-3) in light of Mohit Sharma (supra), expeditiously, preferably within a period of six weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioners and pass speaking order thereafter. Pending applications, if any, stand disposed of."

And whereas petitioner has filed the Ex. Pet. No. 1184/2025 in CWP No. 15271/2025 titled as Jeevan Lal Vs State of HP & Ors.:-

"Notice. Mr. Raj Negi, Deputy Advocate General, appears, waives and accepts service of notice on behalf of the respondents. Response/compliance affidavit, as prayed, be filed within four weeks. List for consideration on 11.09.2026."

And whereas petitioner was appointed as Lecturer (School-New) English on contract in the year 2021 and his services were regularized in the year 2023. As per Finance Department letter No. Fin-(PR)B(7)-1/2021-loose dated 04.04.2026, it was decided that the an employee appointed on a contract basis on or before 03.01.2022 shall receive the benefit of Rule 7 (A) only after completion of two years of regular service.

Now therefore, in compliance to the order of Hon'ble High Court in Ex. Pet. No. 1184/2025 in CWP No. 15271/2025 titled as Jeevan Lal Vs State of HP & Ors., the petitioner is allowed Rs. 47000/- after two years of regular service. The Principal/DDO concerned school is hereby directed to fix the pay of petitioners and release the arrears as per Finance Department instructions issued from time to time and compliance report be sent to this Directorate immediately, the entry be also made in the service book of the individual concerned.

May inform parties accordingly.
