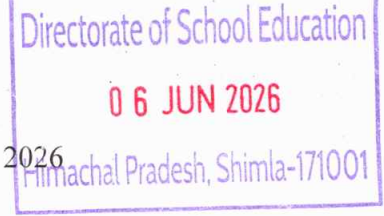

ORDER

In the matter of:- CWP No. 6017/2026-titled as Sunil Kumar, TGT (Arts) V/s. State of HP and others.

The petitioner has filed present CWP No. 6017 of 2026 in the Hon'ble High Court vide which sought his transfer from GSSS Lahru, Distt. Kangra to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on dated 27.04.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

In light of the prayer made by the petitioner, this petition is disposed of with the direction representation (Annexure P-7) filed by the petitioner be decided by the Competent Authority within a period of eight weeks from today in terms of the contents therein. Pending miscellaneous application(s), if any, also stand disposed of.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 11.05.2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Sunil Kumar, TGT (Arts) submitted fresh representation and stated that he is presently working at GSSS Lahru, Distt. Kangra and requested for transfer/adjustment either at GHS Thathwani (HMR), GMS Chamned u/c GSSS Lambloo (HMR), GHS Salouni (HMR), GHS Mair (HMR), GSSS Parol (HMR) against vacant post.

From the perusal of the record it is found that Sh. Sunil Kumar, TGT (Arts), has been serving at GSSS Lahru, Distt. Kangra, since 05.06.2025. Further the institution GSSS Lahru is situated in a soft area of District Kangra, wherein about 98 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected and stands disposed of on the grounds that the petitioner Sh. Sunil Kumar, TGT (Arts) is presently posted at a soft area and in the larger interest of the students, his services are essentially required at GSSS Lahru, Distt. Kangra. All the concerned are intimated accordingly.

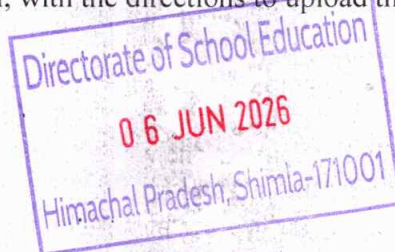
