Accordingly, the said selection trials shall now be conducted as per the following revised schedule:

**Venue: Government Sports Hostel, Chopal, District Shimla**

**Dates: 04.05.2026 to 05.05.2026**

**Reporting Time: 09:00 AM**

It is further ordered and clarified that the selection trials to be conducted at Sports Hostel, Chopal shall be common and composite trials, and the merit so drawn shall be utilized for filling up vacancies of the following Sports Hostels in District Shimla:

**Government Boys Sports Hostel, Rohru, Sports Hostel, Matiana, Sports Hostel, Chopal**

No separate trials shall be conducted for the above-mentioned hostels, and selection of players shall be finalized strictly from the merit of the trials conducted at Chopal only.

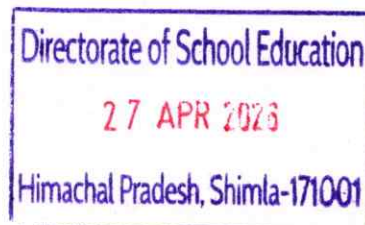
