ORDER

In the matter of: CWP No. 4328/2026- Sh. Ashwani Mehta, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Ashwani Mehta, TGT(NM) previously working in GMS Julahkari u/c G(B)SSS Chamba, Distt. Chamba has filed CWP No. 4328/2025 titled as Ashwani Mehta Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Chamba. The case of the petitioner was listed before the Hon'ble High Court on 02.04.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"As observed hereinabove, the representation to be filed by the petitioner within a period of one week and decision thereupon be taken by the Authority concerned, within a period of two weeks as from the date of the receipt thereof. Till then, the petitioner shall not be forced to join the station to which he stands transferred and he can avail the kind of leave due to him. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 27.04.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Bajori or GMS Sungal u/c GSSS Barour or GMS Haloonda u/c GSSS Sanoh, Distt. Chamba, against vacancy/longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Julahkari u/c GSSS(B) Chamba to GSSS Mehla, Distt. Chamba, against vacancy vide order dated 30.03.2026 with the prior approval of the competent authority. One post of TGT(NM) is lying vacant at GMS Sungal u/c GSSS Barour, Distt. Chamba.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GMS Sungal u/c GSSS Barour, Distt. Chamba, against vacancy without TTA/JT .

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
