ORDER

In the matter of: CWP No. 3704/2026- Smt. Shikha Pathania, TGT(NM) Vs. State of H.P. and others.

Whereas, Smt. Shikha Pathania, TGT(NM) presently working in GMSSS Dand, Distt. Chamba has filed CWP No. 3704/2026 titled as Smt. Shikha Pathania Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred from GMSSS Dand, Distt. Chamba to one of the stations of her choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 25.03.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"As prayed for by learned Counsel for the petitioner, this writ petition is disposed of with the direction that let the representation of the petitioner (Annexure P-2) be considered and decided, sympathetically, by the Department within a period of six weeks from today, by passing a speaking order, after affording an opportunity of hearing to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of accordingly. "

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 27.04.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMSSS Dand, Distt. Chamba to GMS Bhadroya u/c GSSS Lodhwan or GSSS Gagwal or GSSS Lathial or GSSS Maira or GSSS Sidhpur Ghar, Distt. Kangra, against vacancy/longer stayee.

After perusal of relevant record, it is revealed that the petitioner has been working in GMSSS Dand, Distt. Chamba since 16.02.2023 and has completed her normal tenure of three years. Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby transferred from GMSSS Dand, Distt. Chamba to GSSS Lathial, Distt. Kangra, against the vacancy arising due to the retirement of the present incumbent on 30.04.2026, without TTA/JT on her own request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
