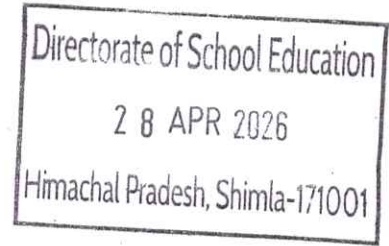

ORDER

Whereas, Sh. Pawan Kumar, Lecturer (School-New) (English) was transferred from GSSS Tutikandi (Shimla) to GSSS Bathalang (Solan) vice Smt. Sunita Chauhan, Lecturer (School-New) (English) and vice versa vide this office order dated 07.04.2026. Feeling aggrieved Sh. Pawan Kumar filed CWP No. 5372/2026 before the Hon'ble Court seeking his suitable adjustment in any school of Municipal Corporation of Shimla on his medical grounds as he is suffering from 80% permanent disability. The case was finally listed before the Hon'ble Court on 22.4.2026 when the case was disposed of with the following directions:-

“In light of the issue raised in the present petition, the same is disposed of with the direction that the petitioner may file a representation for his adjustment at some other nearby station within a week from today and endeavour shall be made by the Authority to adjust him there, if possible, in light of the fact that the petitioner is a physically disabled person. Till the decision on the representation, the petitioner shall not be forced to join the station to which stands transferred in terms of the impugned transfer order and he may avail the kind of leave due to him. Pending miscellaneous application(s), if any, also stand disposed of accordingly.”

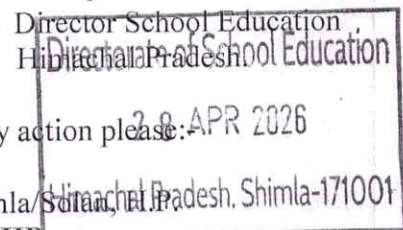
And whereas, in compliance with the directions of the Hon'ble High Court, the petitioner was afforded an opportunity of personal hearing on 28.04.2026. During the course of the hearing, the petitioner submitted a representation and requested to adjust him either at GSSS Phagli/Summerhill/Annadale/Totu against present incumbent by clubbing their stay within the radius of 30 Kms or in the O/o Directorate of School Education or in the O/o State Project Director, Distt. Shimla vice Smt. Kiran Bala, Lecturer (School-New) English as per her consent.

Now, therefore, in view of the facts stated above, the representation of the petitioner is hereby considered sympathetically. Accordingly, Sh. Pawan Kumar, Lecturer (School-New) (English), who is under orders of transfer from GSSS Tutikandi (Shimla) to GSSS Bathalang (Solan) is hereby adjusted in the O/o State Project Director (SS) vice Smt. Kiran Bala, Lecturer (School-New) (English). Further, Smt. Kiran Bala is hereby transferred to GSSS Bathalang (Solan) against vacancy as per her consent & in condonation of short stay, without TTA/JT.

With these observations, representation stands disposed of.
