The Hon'ble High Court has directed the department on the subject cited CWP to consider the case of the petitioners in light of the judgment passed in CWP No. 1638/2024-titled as Mohit Sharma & Anr. Vs State of H.P. & others and pass appropriate orders in accordance with law within a period of four weeks from the date of receipt of copy of this order. The decision so arrived at, shall be communicated to the petitioners.

The above matter was taken up with the Government and the Govt. vide letter no. EDN-C-B(6)22/2025 dated 28.05.2025 has conveyed direction that all such cases may be implemented on case to case basis, being similar situated cases to that of Mohit Sharma (CWP No. 1638/2024-titled as Mohit Sharma), subject to the final outcome of further legal remedy, if any, being exercised by the State.

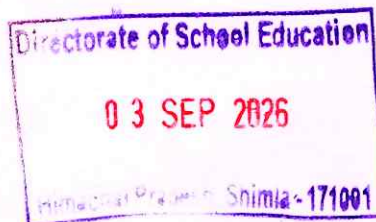
In view of the above, you are hereby, directed to consider the cases of the petitioners in light of judgment passed in CWP No. 1638/2024-titled as Mohit Sharma & Anr. Vs State of H.P. & others, decided on 29.11.2024 and examining the facts from his/her service record if found similarly situated as petitioner(s) in Mohit Sharma's case (supra), the pass detailed speaking order after considering all aspect and extend the benefit of higher stage of pay of Rs. 40,100/- to the petitioners w.e.f. his/her completing two years of regular service subject to the final outcome of further legal remedy, if any, being exercised by the State in this regard. However, the undertaking to this effect may be obtained from the petitioner that the overpayment if any found in the stages shall be recovered from him accordingly.

It may please be treated as **Most Urgent being Court matter.**
