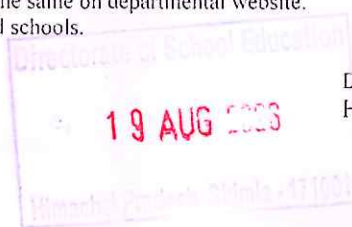

Above pay fixation is subject to verification by the audit. If any recovery is pointed out later on, the official will have to refund the whole amount in lump- sum. An undertaking to the effect may be obtained and pasted in the service book of the individual concerned duly countersigned before the payment of arrears.
