**ORDER**

In the matter of:- CWP No. 5991/2026-titled as Madhu Devi, TGT (Arts) V/s. State of HP and others.

The petitioner has filed present CWP No. 5991 of 2026 in the Hon'ble High Court vide which sought her transfer from GSSS Hatli, Distt. Chamba to her choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on dated 24.04.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

**"...as prayed for, this petition is disposed of with the direction that let representation (Annexure P-1) of the petitioner be decided by the Competent Authority, in the light of the averments contained therein, by passing a speaking order, within a period of six weeks' from today, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly."**

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 19.05.2026 and appeared before the undersigned. During the hearing, the petitioner, Smt. Madhu Devi, TGT (Arts) submitted fresh representation and stated that she is presently working at GSSS Hatli, Distt. Chamba and requested for transfer/adjustment either at GHS Mao u/c GSSS Amri, GSSS Dadh, GSSS Tang Narwana, GSSS Parour or GSSS Baldhar Distt. Kangra against vacant post or longer stayee.

From the perusal of the record it is found that Smt. Madhu Devi, TGT (Arts), has been serving at GSSS Hatli, Distt. Chamba, since 09.03.2022. Further the institution GSSS Hatli is situated in a soft area of District Chamba, wherein about 114 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected and stands disposed of on the grounds that the petitioner, Smt. Madhu Devi, TGT (Arts) is presently posted at a soft area and in the larger interest of the students, her services are essentially required at GSSS Hatli, Distt. Chamba. All the concerned are intimated accordingly.

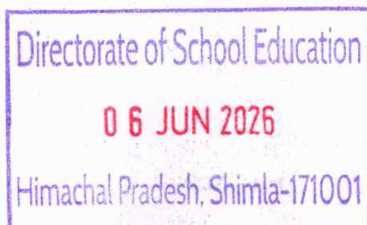
