OFFICE ORDER

In the matter of: CWP No. 1925/2026-titled as Jitender Kumar, Vs. State of H.P &Others.

Whereas, Sh. Jitender Kumar, Lect. Math preferred CWP No. 1925/2026 titled as Jitender Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Gondpur Bulla, Distt. Una, H.P to nearby home town in Distt. Una. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19-02-2026 when the Hon'ble High Court has passed the following orders:-

3. " Accordingly, the present petition is disposed of with a direction to the respondents/authority to decide the undated representation placed at page no.26 of the paper book within a period of six weeks from today, by passing a speaking order and after affording an opportunity of hearing to the petitioner. The decision so taken shall be communicated to the petitioner forthwith. 4. It is made clear that this Court has not expressed anything on the merits of the case, and the authority shall take a decision strictly in consonance with the provisions of law. 5. Petition stands disposed of, so also the pending application(s), if any."

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20-04-2026. He attended the same and submitted his representation in this office, vide which he has requested that he may be transferred from GSSS GSSS Gondpur Bulla, Distt. Una to GSSS Jakhera, Distt. Una, against vacancy being caused due to retirement of present incumbent on 30-04-2026.

In the perusal of the record, it is found that the petitioner is working at GSSS Gondpur Bulla, Distt. Una, H.P. since 22-02-2022, and has completed his normal tenure at his present place of posting. One post of Lect. Math is going to be vacant due to retirement of present incumbent on 30-04-2026 at GSSS Jakhera, Distt. Una, H.P. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Gondpur Bulla, Distt. Una to GSSS Jakhera, Distt. Una, H.P against vacancy being caused due to retirement of present incumbent on 30-04-2026. These orders will be implemented after the retirement of present incumbent on 30.04.2026. The representation of the petitioner is disposed of accordingly.
