**OFFICE ORDER**

In the matter of: CWP No. 2648/2026-titled as Pritam Singh, Vs. State of H.P & Others.

Whereas, Sh. Pritam Singh, Lect. Math preferred CWP No. 2648/2026 titled as Pritam Singh, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Kashmaila, Distt. Mandi, H.P to nearby home town in Distt. Mandi. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 09-03-2026 when the Hon'ble High Court has passed the following orders:-

3. "Accordingly, as prayed for, this petition is disposed of with the direction that let representation (Annexure P-3) of the petitioner be decided by the Competent Authority, in the light of the averments contained therein, by passing a speaking order, within a period of 8 weeks' from today, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly."


In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20-04-2026. He attended the same and submitted his representation in this office, vide which he has requested that he may be transferred from GSSS Kashmaila, Distt. Mandi to GSSS Kanaid, GSSS Slapper, GSSS Dehar, Distt. Mandi, against vacancy/ longer stay by clubbing his/her previous stay within 30 kms.

In the perusal of the record, it is found that the petitioner is working at GSSS Kashmaila, Distt. Mandi, H.P. since 25-11-2023, and has almost completed his normal tenure at his present place of posting. At present there is no post of lect. (Math) lying vacant in schools given by the petitioner in his representation. One Sh. Bhupinder Kumar, Lect. (Math) is working in GSSS Kanaid, Distt. Mandi since 31-05-2025. The petitioner has requested in his representation that he may be transferred to GSSS Kanaid, Distt. Mandi, against longer stayee by clubbing his previous stay radius of 30 Kms.. Keeping in view of the above position, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Kashmaila, Distt. Mandi to GSSS Kanaid, Distt. Mandi, H.P, vice Sh. Bhupinder Kumar, Lect. Math, by clubbing his previous stay, with TTA/JT to Sh. Bhupinder Kumar, Lect. Math. The representation of the petitioner is disposed of accordingly
