ORDER

In the matter of:- CWP No. 2753/2026-titled as Sangita, TGT (Arts) V/s. State of HP.

The petitioner Smt. Sangita has filed present CWP No. 2753 of 2026 in the Hon'ble High Court vide which sought her transfer from GHS Narwandhi Distt. Mandi to her choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 10.03.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

“This Writ Petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided by the competent authority in light of the averments made therein within a period of six weeks from today.”

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 24.04.2026 and appeared before the undersigned. During the hearing, the petitioner, Smt. Sangita, TGT (Arts), submitted fresh representation and stated that she is working at GHS Narwandhi u/c GSSS Sianj, Distt. Mandi (i.e. soft area of Distt. Shimla) and requested for transfer/adjustment at either at GSSS Kummi (MND), GHS Dugrain, GHS Behna (MND) as she is suffering from multiple disease.

From the perusal of the record, it is found that Smt. Sangita, TGT (Arts), has been working at GHS Narwandhi u/c GSSS Sianj, Distt. Mandi since 12.03.2024 and having short stay at present place of posting. Further the institution GHS Narwandhi, is situated in a soft area of district Mandi, wherein about 40 students are enrolled. Further, in CWP No. 2624/2025, titled Shabnam vs. State of Himachal Pradesh, the Hon'ble High Court, as well as the Transfer Policy of the State Government, have emphasized that the normal tenure of posting at a station shall be three years.

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner (Smt. Sangita, TGT (Arts) is presently posted at a soft area station and, in the larger interest of the students, her services are essentially required at GHS Narwandhi (MND). Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
