**ORDER**

In the matter of:- CWP No. 6151/2026-titled as Ajay Kumar, TGT (Arts) V/s. State of HP.

The petitioner Sh. Ajay Kumar, TGT (Arts) has filed present CWP No. 6151 of 2026 in the Hon'ble High Court against this office transfer order dated 22.4.2026, and sought his adjustment. The present CWP was listed before the Hon'ble High Court of H.P. on dated 27.04.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

**“.....this petition is disposed of with the direction that let an appropriate representation be filed by the petitioner for his adjustment at some other station, in light of his physical disability and order be passed upon the said representation of the petitioner, within a period of three weeks as from the date of the receipt thereof, after affording an opportunity of hearing to the petitioner. Till the decision of the representation, the petitioner shall not be forced to join the station to which he stands transferred and he can avail the kind of leave due to him.”**

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 05.05.2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Ajay Kumar, TGT (Arts), submitted fresh representation and stated that he is under order of transfer to GHS Munish Distt. Shimla and requested for his adjustment at GMS Dhamer u/c GSSS Daulatpur (Kangra) as he is suffering from physical disability.

From the perusal of the record, it is found that Sh. Ajay Kumar, TGT (Arts), has been working at from GHS Balol Distt. Kangra since 26.02.2022 and petitioner has completed his normal tenure at present place of posting. The transfer orders of petitioner was issued from GHS Balol Distt. Kangra to GHS Munish Distt. Shimla vice Sh. Manoj Kumar, TGT (Arts) and vice versa basis dated 22.4.2026. Further, the petitioner is 40% handicapped and at present no any post of TGT (Arts) is lying vacant in the choice schools of petitioner but one incumbent Mr. Jugal Kishor, TGT (Arts) is working at GMS Dhamer u/c GSSS Daulatpur (Kangra) w.e.f. 14.10.2022 and completed his normal tenure at present place of posting.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Sh. Ajay Kumar, TGT (Arts) who is u/t from GHS Balol Distt. Kangra to GHS Munish Distt. Shimla is hereby adjusted at GMS Dhamer u/c GSSS Daulatpur (Kangra) vice Mr. Jugal Kishor, TGT (Arts) and vice versa basis (with TTA/JT in r/o Mr. Jugal Kishor, TGT (Arts)). *If the petitioner/ Mr. Jugal Kishor is/are deployed on election duty, he/they shall not be relieved until the completion of the election process.* Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
