ORDER

In the matter of: CWP No. 6163/2025 titled as Sunita Kumari, TGT (NM) Vs. State of H.P. & others.

Whereas, Smt. Sunita Kumari, TGT (NM) previously working in GSSS Bharmar (Kangra) has filed CWP No. 6163/2026 titled as Sunita Kumari, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that she may be adjusted at one of the stations of her choice in Distt. Kangra/Chamba. The case of the petitioner was listed before the Hon'ble High Court on 27.04.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

Without going into the legality of the order under challenge, in light of the fact that the petitioner is stated to be superannuating in just two years, this petition is disposed of with the direction that in the event of the petitioner filing a representation within one week from today for his adjustment at some other station, appropriate call thereupon be taken by the competent authority, sympathetically, within three weeks from the date of receipt thereof. Till decision on the representation, the petitioner shall not be forced to join new place of posting and he may be 1 Whether reporters of the local papers may be allowed to see the judgment? allowed to avail the leave of kind due. Pending miscellaneous application(s), if any, also stand disposed of accordingly.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.05.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be adjusted at GSSS Balera, Distt. Chamba or GSSS Rehan or GHS Kardial or GSSS Khanni, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GSSS Bharmar Distt. Kangra to GSSS Dhullara, Distt. Chamba vide order dated 21.04.2026 in view of CWP No. 3091/2026. At present, one post of TGT (NM) is lying vacant at GSSS Balera, Distt. Chamba.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby adjusted at GSSS School Balera, Distt. Chamba against vacancy without TTA/JT.

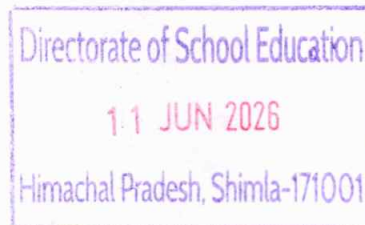
Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
