ORDER

In the matter of:- CWP No. 2584/2026-titled as Ramesh Chand, TGT (Arts) V/s. State of HP.

The petitioner Sh. Ramesh Chand has filed present CWP No. 2584 of 2026 in the Hon'ble High Court vide which sought his transfer from GSSS Ratnari, Distt. Shimla to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 05.03.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

“This Writ Petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided by the competent authority in light of the averments made therein within a period of six weeks from today.”

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 24.04.2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Ramesh Chand, TGT (Arts), submitted fresh representation and stated that he is working at GSSS Ratnari, Distt. Shimla (i.e. soft area of Distt. Shimla) and requested for transfer/adjustment at either at GMS Gangoti, GSSS Panjalag, GSSS Ahju Distt. Mandi or GSSS Kunsal (KGR) on account of completion of normal tenure of posting.

From the perusal of the record, it is found that Sh. Ramesh Chand, TGT (Arts), has been working at from GSSS Ratnari, Distt. Shimla since 22.12.2020. Further the institution GSSS Ratnari, is situated in a soft area of district Shimla, wherein about 19 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 “Transfer to a particular place of choice cannot be claimed as a matter of right.” Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner (Sh. Ramesh Chand, TGT (Arts) is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GSSS Ratnari Distt. Shimla. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
