ORDER

In the matter CWP No. 3124/2026 – Nisha Devi VS State of HP and other.

Whereas, Smt. Nisha Devi, TGT (Med), presently working at GHS Kandha-Sorta u/c Kutahchi, District Mandi, filed CWP No. 3124/2026 titled Smt. Nisha Devi Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking transfer to a station of her choice in District Kinnaur. The case was listed before the Hon'ble High Court on 17.03.2026 and the Hon'ble Court disposed of the writ petition with the following directions:

"This writ petition is disposed of with the direction that the representation filed by the petitioner be decided by the Competent Authority in light of the averments made therein within a period of eight weeks from today. Pending miscellaneous application(s), if any, also stand disposed of."

In compliance with the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 28.03.2026. She appeared on the scheduled date and was heard at length. During the hearing, the petitioner submitted that her husband is posted as Section Officer, HPFAS in the office of the Deputy Director of School Education, Kinnaur at Reckong Peo . She further submitted that she has two minor children (aged about 3 years) and due to her distant posting, she is facing serious hardship in their upbringing, proper care, and emotional support at this crucial stage. She, therefore, requested adjustment near her husband's place of posting on a couple case basis.

After perusal of the relevant record, it is revealed that the petitioner is presently posted at GHS Kandha-Sorta u/c Kutahchi, District Mandi w.e.f. 28.03.2022 and has already completed more than the normal tenure at the said station. As per Clause 5.4 of the Transfer Policy, where both husband and wife are serving under the State Government, efforts should be made to post them at the same station or nearby stations as far as possible. At present, no vacancy is available in the nearby schools of Reckong Peo where her husband is posted. However, five posts of Lecturer/Lec(School New) are lying vacant in DIET Kinnaur at Reckong Peo and the said institution is facing an acute shortage of staff.

Therefore, keeping in view the above facts, the provisions of the Transfer Policy, and her academic qualifications i.e. B.Sc. (Medical) and Post Graduation in Zoology, Smt. Nisha Devi, TGT (Med) is hereby transferred from GHS Kandha-Sorta u/c Kutahchi, District Mandi and mal-adjusted in DIET Kinnaur at Reckong Peo against the vacancy of Lecturer/Lecturer (School New) with immediate effect, on a couple case basis, without TTA/JT on his own request . She shall teach Science subjects and handle academic as well as Science-related interventions at DIET Kinnaur in view of her qualifications. The representation of the applicant is disposed of after due consideration. All the concerned be intimated accordingly.
