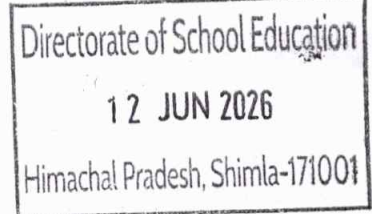

ORDER

Whereas, Sh. Tek Chand, DPE/Lect. Phy. Education who is presently posted at GSSS Danni, Distt. Kangra filed in COPC No. 90/2026 in CWP No. 17929/2025 against the office order dated 26.12.2025 vide which his representation was rejected.

The case was listed before the Hon'ble Court on 22.05.2026 when the case was disposed of with the following directions:-

“Compliance affidavit has been filed, alongwith Office Order dated 26.12.2025, wherein, it has been stated that representation of the petitioner has been considered and rejected. onfronted with this, learned counsel for the petitioner states that post of Yoga Instructor at DIET, Chamba is lying vacant, where the petitioner can be adjusted since he is on the verge of retirement. Therefore, in this view of the matter, the respondents are directed to consider the case of the petitioner afresh sympathetically since he is on the verge of retirement. The petitioner is directed to make a representation in this respect within a period of two days and thereafter the respondents are directed to decide the same within a period of ten days. As prayed for, list on 15.06.2026”.

And whereas, earlier petitioner was transferred from DIET Chamba (CBA) to GSSS Danni (KGR) against vacancy with TTA/JT on dated 24.06.2025 and joined his duties on 27.06.2025. After joining at GSSS Danni (KGR) he has filed CWP No. 17929/2025 and same was listed on 19.11.2025 when the Hon'ble High Court disposed of the case with the direction to decide the fresh representation of petitioner. In compliance to Hon'ble High Court direction petitioner was called for personal hearing on 09.12.2025 and during the course of hearing petitioner has requested that he is on the verge of his retirement and submitted his representation wherein he has given two stations of his choice i.e. GSS Dugli (CBA) or GSSS Kalhel (CBA). But his representation was considered and rejected by the respondent department by way of passing detailed reasoned speaking order in view of CWP No. 17929/2025.

And whereas, in compliance of Hon'ble High Court direction petitioner was granted opportunity for personal hearing on 10.06.2026. During the course of hearing petitioner has requested that keeping in view of his retirement i.e. in June 2027 he may kindly be transfer to DIET Chamba against the vacant post of Yoga Teacher or GSSS Dugli (CBA) or GSSS Kalhel (CBA) against longer stayee.

And whereas, the representation has been examined thoroughly in light of the existing transfer policy and administrative exigencies. Upon perusal of the service record, the following facts have been emerged:


And whereas, the petitioner is on the verge of retirement in June 2027. However post of Yoga Teacher is lying vacant in DIET Chamba but the post of Yoga Teacher is equivalent to P.E.T. or Drawing Master. Hence it is not feasible to transfer him against the vacant post of Yoga teacher. However, keeping in view of his retirement the request of petitioner is considered against longer stayee at GSSS Dugli (CBA) vice Sh. Lekh Raj Kapoor DPE/ Lect. Phy. Education who is working there since October 2022.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathetically and petitioner i.e. Sh. Tek Chand, DPE/Lect Phy. Education who is posted at GSSS Danni (Kangra) is hereby transferred without TTA/JT to GSSS Dugli (CBA) vice Sh. Lekh Raj Kapoor DPE/ Lect. Phy. Education and vice versa, with TTA/JT.

With these observations, representation stands disposed of.


