Office Order

V/s State of H.P. was extended in r/o the petitioner in compliance to the orders passed by Hon'ble High Court of HP.

The CWP No. 11802/2026 titled as Jatinder Thakur V/s State of H.P. was listed before the Hon'ble High Court when the Hon'ble High Court has passed following orders:-

"This petition is disposed of with the direction that after the adjudication in Letters Patent Appeal by the Hon'ble Division Bench of this Court, which has been preferred by the State against judgment dated 07.04.2025, passed by the Hon'ble Coordinate Bench of this Court in Inder Singh Thakur and others Versus State of Himachal Pradesh and others, in the event of the petitioners filing independent representations within four weeks, the same be decided by the Authority within 8 weeks as from the date of the adjudication of the Hon'ble Division Bench. Pending miscellaneous application(s), if any, also stand disposed of."

In view of the facts and circumstances stated above, the judgment passed by the Hon'ble High Court in CWP No. 4830/2023, titled Inder Singh Thakur, has been assailed by the this Department by way of filing an LPA.

Further, in terms of the orders passed by the Hon'ble High Court in CWP No. 11802/2026 titled as Jatinder Thakur & ors. V/s State of H.P., the representation of the petitioner is required to be considered and decided after the final outcome of the LPA filed by the this Department. Accordingly, the benefits vide office order dated 22.07.2026, in r/o the petitioner in CWP No. 11802/2026 titled as Jatinder Thakur V/s State of H.P. cannot be released till the final outcome of the LPA filed in the case of Sh. Inder Singh Thakur filed in the Hon'ble Division Bench.

Hence, the representation of the petitioner is hereby decided in terms of the order passed by the Hon'ble High Court of Himachal Pradesh. All the concerned be intimated accordingly.
