filing the reply entire responsibility will be yours.

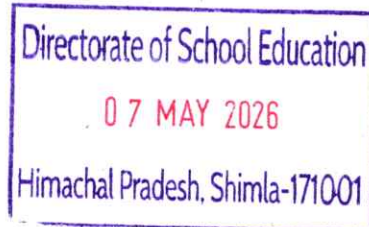
