ORDER

In the matter of:- CWP No. 2147/2026-titled as Anil Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 2147 of 2026 in the Hon'ble High Court vide which sought his transfer from GHS Devnagar Distt. Shimla to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on dated 27.02.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

..... the direction that let the representation of the petitioner be decide by the Authority concerned within a period of eight weeks from today by affording an opportunity of hearing to him. The aspect of academic session can be taken up for consideration by the Authority while deciding the representation.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 24.03.2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Anil Kumar, TGT (Arts) submitted fresh representation and stated that he is working at GHS Devnagar Distt. Shimla and requested for transfer/adjustment at GSSS Sandhu, GSSS Lalpani, GSSS Portmore Distt. Shimla on account of completion of normal tenure of posting and couple case basis.

From the perusal of the record it is found that Sh. Anil Kumar, TGT (Arts), has been serving at Government High School, Devnagar Distt. Shimla, since 21.02.2021. Further the institution GHS Devnagar, is situated in a soft area of district Shimla, wherein about 30 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected and stands disposed of on the grounds that the petitioner (Sh. Anil Kumar, TGT (Arts) is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GHS Devnagar Distt. Shimla. All the concerned are intimated accordingly.
