ORDER

In the matter of:- CWP No. 175/2026-titled as Rakesh Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 175 of 2026 in the Hon'ble High Court vide which sought his transfer from GMS Thaloga u/c GSSS Telka Distt. Chamba to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on dated 06.01.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

..... Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of the transfer policy.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 06.04.2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Rakesh Kumar, TGT (Arts) submitted fresh representation and stated that he is working at GMS Thaloga u/c GSSS Telka Distt. Chamba and requested for transfer/adjustment either at GSSS Banikhet, GSSS Dalhousie, GSSS Chuhan, GSSS Telka Distt. Chamba on account of completion of normal tenure of posting. Additionally, the Govt. has imposed complete ban on transfers vide office order No. Per (AP-B)B(6)-1/2013 dated: 28th June, 2025.

From the perusal of the record it is found that Sh. Rakesh Kumar, TGT (Arts), has been serving at GMS Thaloga u/c GSSS Telka Distt. Chamba, since 21.01.2015. Further the institution GMS Thaloga, is situated in a soft area of Dalhousie district Chamba, wherein about 16 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected and stands disposed of on the grounds that the petitioner (Sh. Rakesh Kumar, TGT (Arts) is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GMS Thaloga u/c GSSS Telka Distt. Chamba. All the concerned are intimated accordingly.
