OFFICE ORDER

In the matter of: CWP. No. 3362/2026-titled as Sh. Inder Singh, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Inder Singh, Headmaster, who is presently working in GHS Mihar, U/C GSSS Gibhi, Distt. Kullu, H.P has filed CWP No. 3362/2026- titled as Inder Singh, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Mihar, U/C GSSS Gibhi, Distt. Kullu, H.P to nearby his native place in Distt Mandi, H.P, against vacancy. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 20-03-2026, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"3. Without making any observation on the merit of the case, this writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-2, shall be decided by the competent Authority, in light of the averments made therein within a period of 8 weeks from today, by passing a speaking order, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 20-04-2026. He attended the same and submitted his representation in this office, vide which he has requested that he is on verge of retirement on 31-12-2026. So, he may be transferred from GHS Mihar, U/C GSSS Gibhi, Distt. Kullu, H.P to GHS Alsoo, U/C GSSS Dehar, Distt. Mandi, H.P, against vacancy.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Mihar, U/C GSSS Gibhi, Distt. Kullu, H.P. The petitioner is going to be retire on 31-12-2026. At present the post of Headmaster is lying vacant at GHS Alsoo, U/C GSSS Dehar, Distt. Mandi, H.P. The petitioner has given willingness for his transfer to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred from GHS Mihar, U/C GSSS Gibhi, Distt. Kullu, H.P to GHS Alsoo, U/C GSSS Dehar, Distt. Mandi, H.P, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
