**ORDER**

Whereas, Smt. Hishey Butith Lect./Lect.(SN) Pol.Science presently posted at GSSS Kaza, Distt. Lahaul & Spiti, filed CWP No. 2967/2026 before the Hon'ble High Court seeking direction to respondent to decide her pending representation wherein she has requested for her transfer from GSSS Kaza (L&S) to the station of her choice i.e. GSSS Rangrik (L&S), as she has completed her normal tenure at present place posting.

The case was listed before the Hon'ble Court on 13.03.2026 when the case was disposed of with the following directions:-

**“Learned counsel for the petitioner submits that the petitioner has filed representation (Annexure P-1) with regard to issues raised in the petition, but the same has not been decided by the authority concerned till date.**

**Accordingly, as prayed for, this petition is disposed of with the direction that let representation (Annexure P-1) of the petitioner be decided by the competent authority, in the light of the averments contained therein, by passing a speaking order, within a period of 8 weeks from today, in accordance with law, pending miscellaneous application, if any also stand disposed of accordingly.”**

**And whereas,** in compliance of Hon'ble High Court directions, the petitioner was granted a personal hearing on 19.05.2026. During the course of hearing petitioner has informed that she is posted in GSSS Kaza (L&S) since 2006, and completed her normal tenure, and now this school has been affiliated with CBSE Board, therefore, she needs to be shifted from the CBSE School to the HP Board school i.e. GSSS Rangrik (L&S) against vacancy.

**And whereas,** while examining her representation it is found that at present Smt. Hishey Butith Lect./Lect. (SN) Pol. Science is working at GSSS Kaza (L&S) w.e.f. 2006 as PTA and her services were regularized in 2018 in the same school & has completed her normal tenure.

**Now therefore,** after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and petitioner i.e. Smt. Hishey Butith, Lect./Lect.(SN) Pol. Science who is presently posted at GSSS Kaza (L & S) is hereby transferred/adjusted to GSSS Rangrik (L& S) against vacancy, without TTA/JT as per her request. Further, Smt. Hishey Butith Lect. Pol.Science is being deputed back to GSSS Kaza (L&S) due to high enrollment of students i.e. 24 in said subject with immediate effect till the joining of Lecturer Pol. Science (CBSE) at GSSS Kaza (L&S). She will not be entitled for any TA/DA.

With these observations, representation stands disposed of.
