**APPOINTMENT TO THE POST OF CHAIRPERSON IN HIMACHAL PRADESH  
PRIVATE EDUCATIONAL INSTITUTIONS REGULATORY COMMISSION, SHIMLA.**

1. In continuation of the advertisements issued vide No. EDN-A-Kha(4)-1/2020 dated 13.03.2024 and No. EDUA-B002(1)/2025-EDU-A (263498) dated ~~15~~04.2025, applications are invited on plain paper from eligible candidates for filling up the vacant post of Chairperson in the Himachal Pradesh Private Educational Institutions Regulatory Commission (HPPEREC), Shimla, in accordance with the provisions of Section 4 of the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2010.

The Chairperson shall be a person of eminence in public life or in the field of higher education, or a person who has held the post of Secretary or above in the Government of Himachal Pradesh or an equivalent post in the Government of India for a period of not less than three years.

The Chairperson shall be appointed by the State Government for a term of three years or until attaining the age of sixty-five (65) years, whichever is earlier. The incumbent shall be eligible for re-appointment for a second term, subject to the upper age limit of sixty-five years.

2. Upon expiry of the term of office, the Chairperson shall be ineligible, for a period of three years, for any further employment or assignment in any private educational institution in Himachal Pradesh or in any of its associate offices or companies, whether within or outside the State of Himachal Pradesh, in terms of the provisions contained in Section 4 of the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2010.
3. Eligible and interested candidates can send their application/ Bio-data for the post of Chairperson, Himachal Pradesh Private Educational Institutions Regulatory Commission by post or can deliver by hand at the following address on or before 31.07.2026 (3:00PM).
