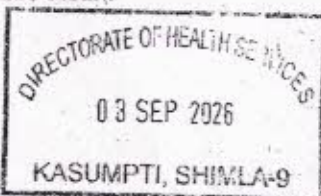
Subject: - Regarding service certificate and incentive certificate in respect of In-service GDOs for NEET-PG 2026.
