At the outset Director, HIPA cum Member Secretary Capacity building commission briefed about the mandate of the capacity building commission earned deliberation started regarding organization of two days workshop during the area of sanitizing started. There are four aspects of Sanitation i.e. i) Solid Waste Management ii) Liquid Waste Management iii) Biomedical Waste Management iv) Industrial Waste Management.

The Department of Rural Development and Urban development Department will give presentation on five best practices successfully implemented in the field and replicable. Tourism Department will also come up with the proposal for training. Some five Star units for management of Wet waste into compost at their own level will be briefed by them.

The participating Department will also put up a proposal for adopting Sangla Model of waste management alongwith compactors atleast at one place in 10 selected Districts. The training will be conducted at HIPA preferably in the last week of the June with 02 days schedule. In the first day of the training presentation on best practices will be given. In the second day discussions will be held in groups regarding problem in the implementation of waste management practices and finally came up with recommendation be submitted to the Govt. Total 70 participants will attend among which ADO, Gram Panchyat

Pradhan, Panchayat Secretaries, regional officers of Pollution Control Board, Executive Officers of Municipal Bodies and Tourism Officers .

The meeting ended with a vote of thanks to the chair.


