At the outset the Chairperson welcomed all the participants in the meeting. Member Secretary apprised everyone regarding the purpose and vision of the State Capacity Building Commission. The following points were discussed during the meeting:-


It was emphasized that there is a need to bring all stakeholders in this regard on a single platform and integrate efforts so that the benefits of the IEC material in context of cyber crime and financial fraud, POSCO Act, awareness regarding drugs etc. can be disseminated at panchayat level.

1. In this context it was decided that a state level workshop shall be organized at the state level where stake holders and ToTs from all departments will participate. The awareness generation workshop shall be aired in all the 88 development blocks of the state which shall be attended by FL CRPs under NRLM, anganwadi workers, and representatives from Education, Health, Welfare and Police departments. All the departments shall nominate 10 to 20 participants who shall attend the workshop at the state level.
2. It was also decided that based on the queries raised by participants of the workshop, FAQs shall be developed.
3. Additional director WCD apprised that camps and trainings for ToTs shall be organized under the Surakshit Bachpan Abhiyan to generate awareness about POCSO and cyber crime.



4. All the departments were directed to check if financial fraud cases have cropped up in Government scheme beneficiaries like MGNREGA, PM KISAN etc.
5. It was informed by the Chairperson that the dates of the workshop shall be communicated separately.
6. IEC material for the workshop shall be provided by Home Department and RBI.

The meeting ended with a vote of thanks to and from the chair.


