At the outset the Chairperson welcomed all the participants in the meeting. Member Secretary apprised everyone regarding the purpose and vision of the State Capacity Building Commission.

The Chairperson raised the issue of Green and renewable energy as the Himachal Pradesh Government is now emphasizing on the shift to E-vehicles and Environment friendly infrastructure and energy sources. The departments of Environment, Technical Education, ITI, Disaster Management, HPKVN, Electricity Board, HIMURJA, and HIPA briefed about what all activities they are taking up to address the issues of Climate Change and increasing awareness with respect to the same.

It was decided that one and half day work shop with 6 Sessions will be organized at HIPA in the last week of July which shall cover the topics of

- Climate Change and Water Drainage (2 Sessions)
- Compensatory afforestation (1 Session)
- Shift to E-Vehicles and minimizing the emissions
- Receding glaciers and impact of Climate change. (1 Session)

- Omnibus presentation by Director Environment where he shall give the presentation on District Environment action plan covering the areas of rain water harvesting, bio medical/plastic waste.
- Waste disposal in rural areas and the best practices of any one district of Himachal Pradesh.

Each Session will have a presentation of 25 minutes, a lecture by the Faculty for 25 minutes and 20 minutes Q&A round.

It was also decided that the Government of Himachal Pradesh shall request for grants of funds for State Capacity Building Commission for carrying out the Capacity and Training activities. A some of Rs. 2 Crores shall be demanded for carrying out work shops ( One Crore) and intra state tour of various stake holders (One Crore). The same can be earmarked as a percentage from training budget of various departments and these funds shall be managed by H.P. Institute of Public Administration under the guidance of Secretary Training.

The meeting ended with a vote of thanks to and from the chair.
