The Chairperson raised the issue for discussion on the increasing menace of narcotic drugs and it's impact on the society, especially youth. It was asserted that it's a matter of grave concern for one and all. A consolidated approach and joint efforts of departments are need of the time.

Following directions were given to the departments..

Welfare Department.

The department of Social Justice and Empowerment(WCD and ESOMSA)shall organise awareness camps and main focus to be on the teenagers. Director WCD to brief Director ESOMSA regarding the same.

The NGOs who are doing good work in this field to be associated to create more awareness and broaden the scope of this campaign.

Police Department.

The Police department to create a focused task force for which provision of funds should be worked out as vital information network would require adequate resources.

The IOs doing good work in curbing this menace must be suitably rewarded.

Rural Development and Panchayati Raj..

Director RD&PR to conduct a meeting with different departments and stakeholders to organise further programmes involving the PRIs, CRPs and Block Development officers.

HPKVN

HPKVN to create awareness in colleges and institutions and prepare IEC material on the issue.

Technical Education..

Director Technical Education was telephonically directed by the Chairperson to start workshops on Drug Awareness in ITIs.

In the meeting that followed with same participants on the issue of Mahila Thanas etc. it was decided that the CDPOs of welfare department should be sensitized on the presence and working of Mahila Thanas.

Director General of Police will be requested for holding a meeting with different stakeholders and departments to discuss POCSO, Juvenile Justice, Prosecution Statistics and Nirbhaya Fund.

Three Webinars will be organized for supervisors and Anganwari workers which will be addressed by Director WCD, Additional Director HIPA and an officer of Police department sensitizing them on the issues of drug abuse, Mahila Thanas etc.

Above all it was decided that an Appeal to Public from Hon'ble Chief Minister Himachal Pradesh be drafted addressing the issue of Drug Awareness. The All India Radio/FM be asked to conduct interviews of various officers on this subject to make the message reach out to maximum number of people.
