



Terms & Conditions and Eligibility criteria for the post of District Child Protection Officer (DCPO).

1. The appointment shall be purely temporary and shall initially be for a period of 1 year from the date of appointment.
2. The terms/ services can be extended beyond one year on yearly basis up to 65 years of age or up to five years of service under Mission Vatsalya Scheme or till the scheme is operational, whichever is earlier subject to satisfactory work and good conduct.
3. Appointment can be terminated any time by serving a notice of 7 days, if services or conduct are not found satisfactory.
4. Once the scheme is over and the grant / funds cease from the Govt. of India, this post will stand automatically abolished and appointment will also stand dispensed with.
5. Age of the applicant as on 01.01.2026 should be 58 to 62 years.
6. **Required Educational Qualification :**
 - i. Post Graduate degree in Social Work/ Sociology/Child Development/ Human Rights/ Public Administration/ Psychology / Psychiatry/ Law/ Public Health/ Community Resource Management from a recognized University.
 - ii. At least 3 years experience of working with the Govt./ Non-Government Organization in Documentation, training & Capacity Building, Project formulation/ implementation, monitoring and supervision preferably in the field of Women & Child Development / Social Welfare.
 - iii. Proficiency in computers.
7. The appointee shall be an employee of the Himachal Pradesh State Child Protection Society (HPSCPS) and not of the State Government and shall be paid fixed salary as prescribed by the Govt. of India under Mission Vatsalya Scheme from time to time.
